- Submission of the Utilisation Certificate in due time.
- All other general conditions of financial propriety and fiscal discipline.
- Ensure that Procurement of goods and Services are done through e- procurement as per OM.N FEB(eGV)03/2015/61 dated 5th August, 2015 of Finance (Estt.-B) Department.

The expenditure is debitable to the Head of Account, 2401-Crop Husbandry- 00- 800- other expenditure, 380 Rashtriya Krishi Vikas Yojana (RKVY)- 000,- 32- Grants in Aid General(Non Salary) - 99 others (State Share), GA (Plan) for the year 2016-17.


