The following conditions shall strictly be followed while drawing fund, incurring expenditure and implementing the above scheme by the implementing authority.


- All the financial rules, procedures and formalities as per Assam Financial Rules.

- VAT shall be deducted at the source and deposited into the State Exchequer by Treasury Challan.
- Ensure that the scheme is completed within the estimated cost in all respect without involving cost and time over run.
- Submission of the Utilization Certificate in due time.
- Procurement of goods and services to be done through e-Procurement as per O.M.FEB (e GU) 03/2015/61, dtd 05.08.2015 of Finance (Estb.B) Department.
- Technical sanction to be issued before execution of work.
- All other general conditions of financial propriety and fiscal discipline.

The expenditure is debitable to the Head of Account, 2401-Crop Husbandry, 00- 800 Other Expenditure- 3807 *Rashtriya Kirishi Vikas Yojan (RKVY)*-000- 32 Grants in Aid General (Non Salary)- 99 Others, Central Share- CSS for the year 2017-18.
