

Clause No	Existing Clause	Revised/Additional Clause
Clause no: D-4 (Terms & Condition of RFE)	JV members with technical experience not relating to the Terms of the RFE (Request for Empanelment for Allotment of Oil Palm Districts) shall not be accepted.	The bid application shall be rejected if a minimum of two members of the JV do not possess the technical experience relating to the Terms of the RFE (Request for Empanelment for Allotment of Oil Palm Districts).
Annexure -IV Clause No -B.	The Joint Venture should be between such firms, which either have cultivation/plantation/development experience of Oil Palm/Plantation Crops OR processing/Refining of Oil Palm/Edible Oil OR both.	The Joint Venture should be between two such firms, which either have cultivation/plantation/development experience of Oil Palm/Plantation Crops OR processing/Refining of Oil Palm/Edible Oil OR both. In case of a JV formed with three firms, minimum of two firms should have the experience of cultivation or processing or both as mentioned above.
Annexure -IV Clause No -C	JV members with technical experience not relating to the Development of Oil Palm plantation & processing shall not be accepted.	The bid application shall not be accepted if a minimum of two members of the JV do not possess technical experience relating to the terms of the RFE (Request for Empanelment for Allotment of Oil Palm Districts).
