

**Minutes of 2nd Meeting of State Level Executive Committee(SLEC) under

A meeting of State Level Executive Committee (SLEC) under PKVY (NMSA) 2017-18 was held on 9/6/2017 at 2p.m. under the Chairmanship of Sri K.K Mittal, IAS, Additional Chief Secretary and Agricultural Production Commissioner, Department of Agriculture, Government of Assam.

Abdul Batin Chowdhury (implementing Officer, PKVY) explained the purpose of the meeting. He presented the status of the scheme. After thorough discussion and as per fund allocation by the Govt. of India vide letter No:2-1/2017-Org.fmg dated: 25th, April,2017,amounting Rs.2413.311 lakhs, the following decisions were taken by the committee.

1. The SLEC has approved the production Annual Action Plan against committed liabilities for the year 2015-16 being implemented during 2016-17 for 220 no's of existing clusters for **Rs. 952.16033** lakhs including 1% administrative cost for the year 2017-18.
2. Production Annual Action Plan for 220 no's of existing clusters for second year activity for the year 2017-18 amounting to **Rs. 1113.17756** lakhs including 1% administrative cost has been approved.
3. Marketing Annual Action Plan for 220 no's of existing clusters for the year 2017-18 amounting to **Rs. 888.8** lakhs has been approved.
4. Production annual action plan for 300 no's of cluster for **Rs 2166.60** submitted in executive meeting held at New Delhi on 11th May is also approved.
5. Keeping in view of the Speech by Hon'ble Prime Minister and Chief Minister, Assam, production Annual Action Plan proposal for 1000 (fresh) clusters amounting to **Rs.7544.2** lakhs for the year 2017-18 which was prepared, is approved by the Chairman.

6. A new PKVY cell with internet facility and a Technical Assistant having M.Sc(Agri.) degree and a Computer cum Accounts Assistant having MCA degree is to be engaged on contractual basis for database management and DBT to happen after receiving sanction from GOI for the year 2017-18.
 7. In order to simplify and expedite the fund release procedure and SLEC suggested that the challans of item/inputs received by the District/Subdivision is to be verified by ADO/Sr. ADO concerned for fund release. In case of construction of vermi-compost unit and traditional organic input production unit, same procedure may be followed.
 8. In the meeting it is also approved to empanel ~~and~~ the companies/manufacturer for different organic inputs needed for organic production with formation of expert committee to be headed by Dr. Sarat Saikia, Chief Scientist, HRS, Kahikuchi, AAU.
 9. Chairman suggested to float EOI for marketing consultant for PGS product to be marketed.
 10. The Committee also proposed to develop Assam Organic Logo along with tag line. Suggestions may be taken from www.mygov.in website.
 11. The committee also approved the expenditure to be made for committed liabilities and interest amount earned in PFMS account of PKVY to be utilized for ongoing scheme expenses including 1% administrative cost.
 12. The committee also approved the cancellation order for PROM as the R1 party is already blacklisted. So, R2 party may be asked to supply PROM to the farmers after checking laboratory report.
 13. One casual labour may be used time to time as and when required.

The meeting ended with a vote of thanks offered by Nodal officer, PKVY.
