Hence, the State shall be required to contribute its matching share for activities of 2016-17 as per existing sharing pattern of 90:10 between Centre and the State for implementation of NFSM-CC-Jute during 2016-17.


The following conditions shall strictly be followed while drawing fund incurring expenditure and implementing the above scheme by the implementing authority

- c) Comply with all the provision of the AFRBM, Act, 2005.
- d) VAT shall be deducted at the source and deposited into the State Exchequer by the contractor.
- e) Ensure that the scheme is completed within the estimated cost in all respect with in involving cost and time over run.
- f) Submission of the utilisation Certificate in due time.
- g) Procurement of goods and services to be done through e-Procurement as per O.M. No. 126/03-03/2015/61, dtd 05.08.2015 of Finance (Esst.B) Department.
- h) All other general conditions of financial propriety and fiscal discipline
- i) And as per the conditions laid down by the GOI vide letter No. 3-1/2014-CI, dated 9-7-2014.

The expenditure is debitable to the Head of Account - 2401- Crop Husbandry - 00-108- Commercial Crops, - 4732- National Food Security Mission-000-32 Grants in Aid - 99 others (Plan) for the year 2016-17.
