With reference to above, I am directed to convey the sanction of the Governor of Assam for an expenditure not exceeding **Rs.20.31 lakh (Rupees twenty lakh thirty one thousand) only under the centrally sponsored scheme, Pradhan Mantri Krishi Sinchayee Yojana (PMKSY), Per Drop More Crop (PDMC) (Micro Irrigation)** as State Share for the year 2016-17 subject to availability of fund and as per fund released by the Government of India vide their letter F.No.38-1/2015-AE/Extn.Desk, dtd 21.10.2015, Rs.147.89 (L) for General Category, F.No.38-1/2015-AE/Extn Desk, dtd 21.10.2015, Rs.12.65 (L) for SC category, F.No.38-1/2015-AE/Extn.Desk, dtd 21.10.2015, Rs.22.72 (L) for ST category and revalidated by GOI for the year 2016-17 vide F.NO.38-1/2016-AE, dtd. 05-05-2016.

The following conditions shall strictly be followed while drawing fund, incurring expenditure and implementing the above scheme by the implementing authority:

- All the financial rules, procedures and formalities as per Assam Financial Rules.
- The Central Vigilance Commission's guidelines.
- Comply with all the provision of the AFRBM Act, 2005.
- VAT shall be deducted at the source and deposited into the State Exchequer by Treasury Challan.
- Ensure that the scheme is completed within the estimated cost in all respect without involving cost and time over run.
- Submission of the Utilization Certificate in due time.
- Procurement of goods and services to be done through e-Procurement as per O.M.FEB (e GU) 03/2015/61, dtd 05.08.2015 of Finance (Estt.B) Department.
- As per the conditions laid down by the GoI vide their letter, F.No.20-23/2015-Hort., dtd. 29-02-2016,
- All other general conditions of financial propriety and fiscal discipline.


