- e. Ensure that the scheme is completed within the estimated cost in all respect without involving cost and time over run.
- f. Submission of the Utilization Certificate in due time.
- g. Procurement of goods and services to be done through e-Procurement as per O.M.FEB (e GU) 03/2015/61, dtd 05.08.2015 of Finance (Estb.B) Department.
- h. As per the conditions laid down by the GoI vide their letter No.9-29/2015-Org.Fmg, dtd 28.08.2015
- i. All other general conditions of financial propriety and fiscal discipline.

The expenditure is debitable to the Head of Accout, 2401-Crop Husbandary, -00-104-Agricultural Farm, 4891- National Mission on Sustainable Agriculture-000-32- Grants in AidGeneral -99-others Central Share (plan) for the year 2016-17.
